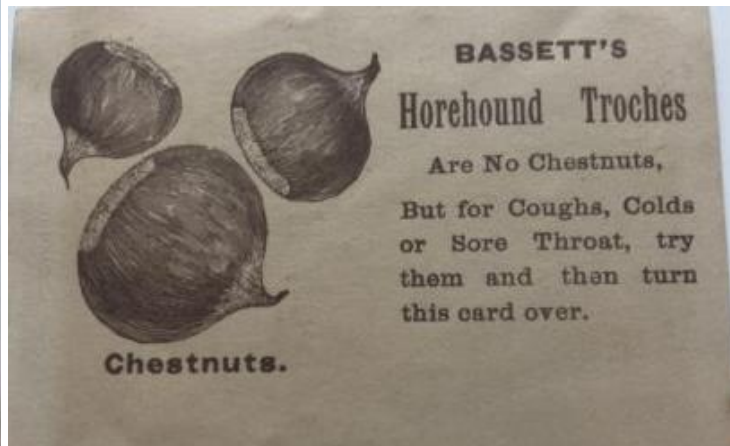
Section 1 - Welcome

Totals number of individuals loaded into the Bassett website: 150,413

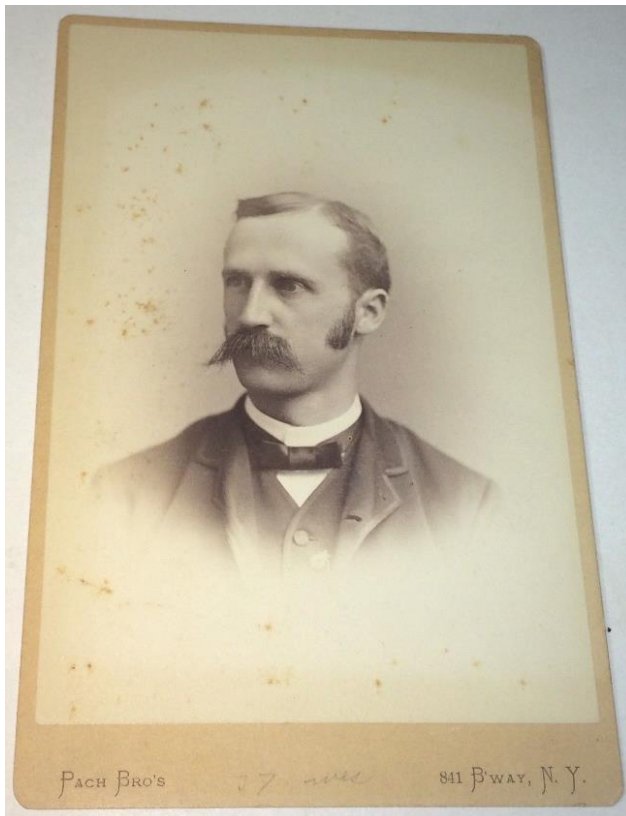

Union Service at Babylon

The Rev. E.D. Bassett honored by Fellow Pastors
Retiring M.E. Preacher Felicitated Upon His Work for Babylon Church
During Six Years Pastorate

Babylon, L.I., March 27 - The Methodist, Presbyterian, Baptist and Episcopal churches of this village united last evening in a union farewell service to the Rev. Edward D. Bassett, pastor of the Methodist Church, who will be pastor of the Methodist Church of Springfield, L.I., after conference. The high regard in which the Rev. Mr. Bassett is held by the people of the community was shown by the fact that the Methodist Church in which the service was held was crowded to the doors.

Prayer was said by the Rev. S. Paul Jefferson, pastor of the Baptist

Church, following which the Rev. R.D. Merrill of the Presbyterian Church who, with the Rev. Mr. Bassett's leaving, becomes the senior pastor of the village, spoke of the work that his fellow pastor had done, stating that it should not be measured by the years of service nor by the tangible results, but by those intangible things accomplished in the spiritual life, which will endure forever.

The Rev. John Good of Lindenhurst spoke of the pastor and extended wishes of good to come to the Rev. Mr. Bassett and to the church.

The Rev. E.J. Burlingham, rector of Christ Episcopal Church of West Islip, expressed his best wishes for the pastor and his congregation, and hoped that the joyfulness and happiness of Christian work that in Babylon has been the lot of the Rev. Mr. Bassett will be his wherever he goes.

The Rev. S. Paul Jefferson, speaking of the good fellowship and hearty co-operation which has existed between the pastors of the town, said that he was sorry to have his fellow pastor leave the village, but declared that in his new post he would put the richness of his years of Christian experience into the work of leading men and women into the Christian life.

Leroy M. Young, for the official board of the church, spoke in appreciation of the work the Rev. Mr. Bassett has done while in his local pastorate.

The Rev. Mr. Bassett bid farewell to his congregation in a few words, speaking of the good will and fellowship he had experienced in the community, and assuring his hearers that he would cherish fond memories of Babylon. He urged them to welcome his successor and to join with him for the furtherance of Christian work.

Mr. Bassett was been pastor of the local Methodist Church for six years, during which time over \$10,000 has been expended in improvements to the church property, and double that amount has been expended for benevolent purposes and general expenses. The membership of the church has been increased by over 125, and the church has had a great material and spiritual growth.

Rev. Edward D. Bassett, formerly of North Manlius and pastor of First Methodist Episcopal Church in Seymour, Conn., who died at his home there Tuesday, will be buried in North Manlius cemetery at 5 o'clock Friday afternoon.

Mr. Bassett is survived by his wife, Mrs. Kate Adams Bassett, former resident of North Manlius and sister of Carl W. Adams of North Manlius, a son, Paul Adams Bassett of Gardner, Mass., and a daughter, Mrs. Elida Cory of Bay Shore, L.I. Services took place in Seymour Thursday afternoon.

Four generations of the Bassett family are represented in this photograph which was taken recently at a birthday celebration. The great-grandfather, William Bassett was born in Erie county, Pennsylvania, May 29, 1874 and came to Montrose township in this county in 1856. He has been a resident of Genesee county almost continuously for 60 years. At present he resides on a farm in Montrose township. His son, Elias Bassett, is at present a resident of Flint having moved to 822 West Kearsley street from the Dye settlement a few days ago. Floyd Bassett, 24, the father of Beatrice Loretta Bassett is also a resident of this city.

Ohio Observer, Hudson, Ohio, Wednesday, June 28, 1848
Court of Common Pleas
Louisa Bassett administratrix of John Bassett dec'd vs. Minerva Ramsey, et als.
Petition for sale of land

The heirs of John Bassett deceased are hereby notified that at the Term of the Court of Common Pleas within and for the county of Summit aforesaid, the Petitioner filed her petition for the sale of the Real estate of the said John Bassett deceased, to pay debts, to wit, about five acres and a half of land situate in the township of Hudson in the county of Summit and State of Ohio, in Lot number forty-five, being the homestead of the said John Bassett, deceased, at the time of his death - and that on the 13th day of June A.D. 1848, the petitioner filed her amended petition praying for the sale of said land, and the assignement of Dower to her the said Louisa Bassett.

In said petition it is set forth that Minerva Ramsey, William Ramsey her husband, Maria Root and Daniel Root her husband, Corintha Bassett, Melissa Oliver and Andrew W. Oliver her husband, Almira Bassett, Sarah Brown and Oliver O. Brown her husband, John Chapman, Matthew Chapman, Harriet Buel and David Buel her husband, Mary Chapman, Ellen Chapman, John Chapman, Jr., Henry Chapman, Solomon Brown, Lemuel Brown, and Mary Brown are heirs at law of the said John Bassett, and whereas there may be other heirs of the said John Bassett deceased, who had whose places of residence are unknown to the Petitioner, they, if any such there are, are also hereby notified of the pendency of the Petition original and amended aforesaid, and that the name will be for hearing at the July Term, A.D. 1848.

Edward W. Bassett, 55, who once held the title of American Ice figure skating champion, died yesterday in his room 4605 Fifth avenue. Bassett was the husband of the late Grace Elaine, a sister of Billy Burke, famous actress, widow of Florenz Ziegfield, who died and was buried in comparative obscurity here in December, 1936.
